## REACH Product Content Declaration

This substance content declaration applies to the following Cree products:

All of the following parts: Schottky diode and rectifier products - TO-220, TO-247, TO-252 and TO-263 form factors.
This declaration applies to these listed products from all assembly and manufacturing sites.

Cree has determined these products (articles) are not subject to EU REACH directive pre-registration requirements because these items are not manufactured in the EU, are not likely to be released into the environment in normally anticipated uses, and total imports into the European Union are below one metric tonne.
